Dear Parent(s)/Guardian(s),

Pursuant to N.J.S.A. 18A:7C-6.6, beginning in Fall 2016 school districts must, by October 1, provide parents or guardians specific information on any State assessment or commercially-developed standardized assessment that may be administered to your child during the school year. It is important to note that all students may not be administered all assessments. Listed below is a proposed template calendar that meets all the criteria of planned assessments that our district will be implementing over the next school year. Certain testing dates may need to be adjusted related to unforeseen schedule changes.

It should be noted that on Tuesday, July 5, 2022, Governor Murphy signed P.L.2022, c.60 (ACS for A-3196/S-2349), which requires the State Board of Education to administer the New Jersey Graduation Proficiency Assessment (NJGPA) as a field test for the class of 2023. There is no graduation assessment requirement for any student who is expected to graduate with the class of 2023. Students in the class of 2023 must still meet all the other State and local graduation requirements, including but not limited to credit, curriculum, and attendance requirements. The graduation assessment requirements for the classes of 2024 and 2025 remain in place.
